### **About FastTrack**

Until recently there has been no mechanism available for customers to easily move their on-premise deployment to the cloud. While complete automation is not possible due to the complexity of the solution, the Microsoft FastTrack Program and Toolset provide a way to perform a migration with the least effort possible. The migration service provides a guided way to move CRM on-premise instance to the Cloud without the need of reimporting the data and thus reducing time and costs.

The process consists of several steps many are automated and do not require customer input. To qualify for the FastTrack program requires nomination by the Dynamics implementation partner.<sup>1</sup>

# The S&S Dynamics Solution

SIS nominated S&S, who was currently running Dynamics CRM on premise for Sales. SIS assisted Microsoft's migration of S&S from on-premise CRM to cloud-based Dynamics 365 CE with integration to SharePoint on-premise. All customizations were successfully migrated including automating the creation of folders to match the sales opportunity process. SIS replicated customizations using Flow.
